



India Ratings Assigns Mirzapur Nagar Palika Parishad 'IND BB'; Outlook Stable

Ind-Ra-New Delhi-10 April 2017: India Ratings and Research (Ind-Ra) has assigned Mirzapur Nagar Palika Parishad (MNPP) a Long-Term Issuer Rating of 'IND BB'. The Outlook is Stable.

KEY RATING DRIVERS

Mirzapur Nagar has inadequate civic infrastructure. There is lack of proper water supply services, sewerage systems in the town. However, there is scope for an improvement in the infrastructure facilities due to its selection under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) scheme.

Mirzapur jurisdiction is only 38.85 sq km with a population of 2,34,871 Economic activities in the town are not buoyant and taxes on average contributed 8.27% to the total revenue over FY12-FY16. Being a municipality, MNPP's revenue sources comprise tax revenue and non-tax revenue, with average contribution to the total revenue income being 8.27% and 2.04% respectively. The municipality's own non-tax revenue mainly emanates from fees and rental income from municipal properties, with an average contribution of 73.07% and 18.71%, respectively, to the total non-tax revenue during FY12-FY16.

MNPP has a high level of dependence on the state government. It receives compensation in lieu of stamp duty and revenue grants and equity contributions. Revenue compensation and revenue grants cumulatively contributed 88.36% to the total revenue income during FY12-FY16

MNPP reported a moderate financial performance in FY16. Its revenue receipts increase to INR324.35 million in FY16 from INR212.25 million in FY12, at a CAGR of 15.18%. Also, its revenue balance improved to INR98.95 million in FY16 from INR13.71 million in FY12.

ATAL RATING SENSITIVITIES

Positive: A significant improvement in MNPP's operating performance, delivery of civic services and timely execution of AMRUT projects, would be positivator the rating.

Negative: Significant delays in execution of urban civic service projects and deterioration in financial performance of MNPP would be negative for rating.

Mirzapur city lies in the centre of North India, nearly 650 km from both Delhi and Kolkata, almost 89 km from Allahabad and 57 km from Varanasi, Eocated in the state of Uttar Pradesh, Mirzapur is renowned for its famous carpets and brassware industries. Mirzapur is well connected from most of the major Indian cities through railways. The city is surrounded by several hills and is the headquarters of Mirzapur District. About 32 km from Mirzapur is the famous for tress of Chunar.

Vindhyachal temple, kaali kooh and Ashtbhuja Devi temple are major pilgrimage sites. For quite some years Mirzapur has been a destination for tourists, particularly for people from adjoining states owing mainly to the ghats and temples. As of the 2011 census, Mirzapur had a population of 234,871 and literacy rate of 76.47%.
